### Dear Friend of PRASAD Children's Dental Health Program,

Did you know that dental cavities are the single most common chronic childhood disease? In fact, it is estimated that children in the USA miss 51 million school hours every year due to the pain and discomfort of dental disease. ER dental visits doubled between 2000 and 2010; many dental emergencies can be prevented with regular dental visits for as little as \$150, while ER treatment might cost as much as \$1500, and will often address only the symptoms, not the underlying problem.

Since 1998, PRASAD Children's Dental Health Program has been improving children's dental health by providing comprehensive, high quality dental services, through education, prevention, detection and treatment.

In 2014, our program provided dental health education to 4,717 children, and the dental clinic performed 1,168 dental procedures. *We appreciate your continued support, which makes it possible for us to bring happy, healthy smiles to children.*

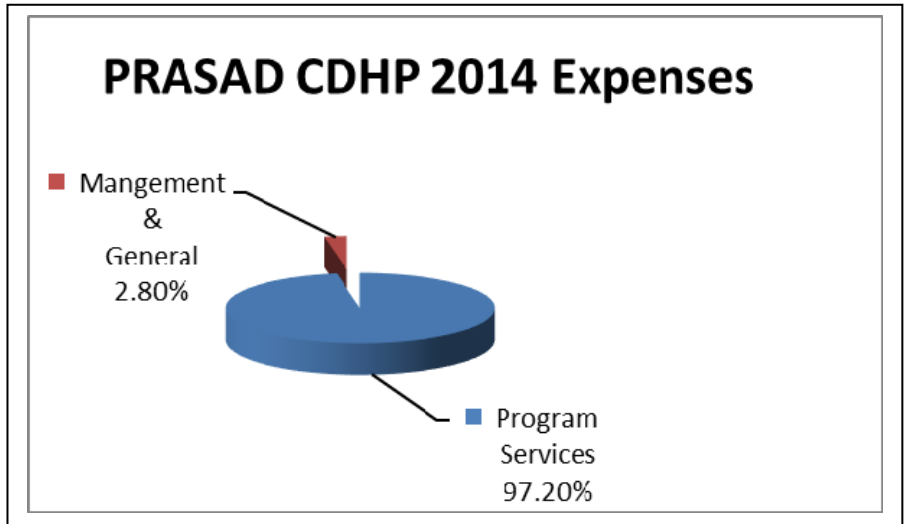
