In the US, dental cavities are the single most common chronic childhood disease. Children with dental problems often lack self-confidence and are reluctant to smile.

Since 1998 your generous support and the dedicated work of our staff and volunteers have made it possible for PRASAD CDHP to provide children with preventive and restorative dental services and dental health education.

In 2016 our program provided dental health education classes to more than 3,500 children. The dental clinic received 675 dental visits and performed more than 2,000 dental procedures.

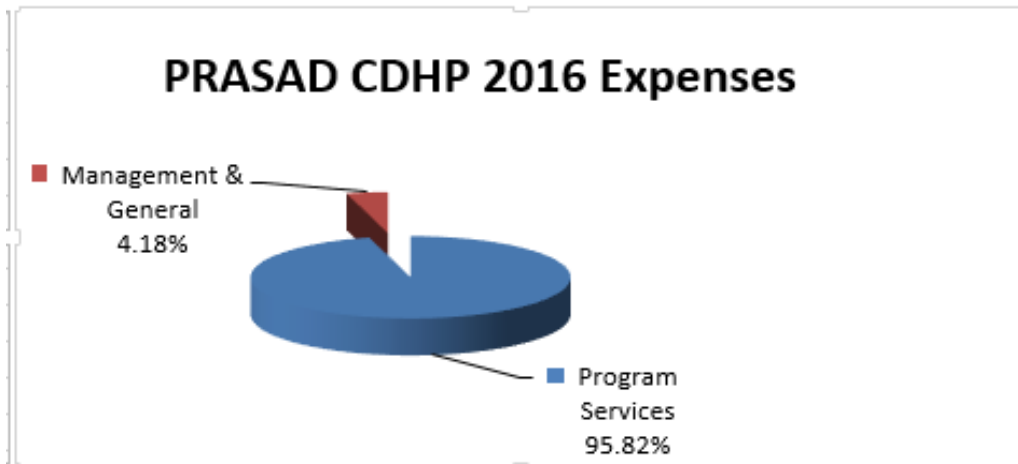
