The mission of PRASAD CDHP is to improve the dental health of children by providing high-quality comprehensive dental services through education, prevention and treatment.

Since the program's launch in 1998, the PRASAD CDHP mobile dental clinic and school-based health center has visited Sullivan County schools to provide health education and preventive and restorative dental services. The convenience of access to these services on school premises is an invaluable benefit in a county without public transportation and many low-income families.

We are honored to be a four-time recipient of the Give Kids a Smile Award from the New York State Dental Foundation in recognition of our program's leadership and excellence in maintaining children's oral health.

In 2019 our program provided dental health education classes and toothbrushes to more than 4,600 children. The dental clinic provided 839 dental visits and performed 2,546 dental procedures.

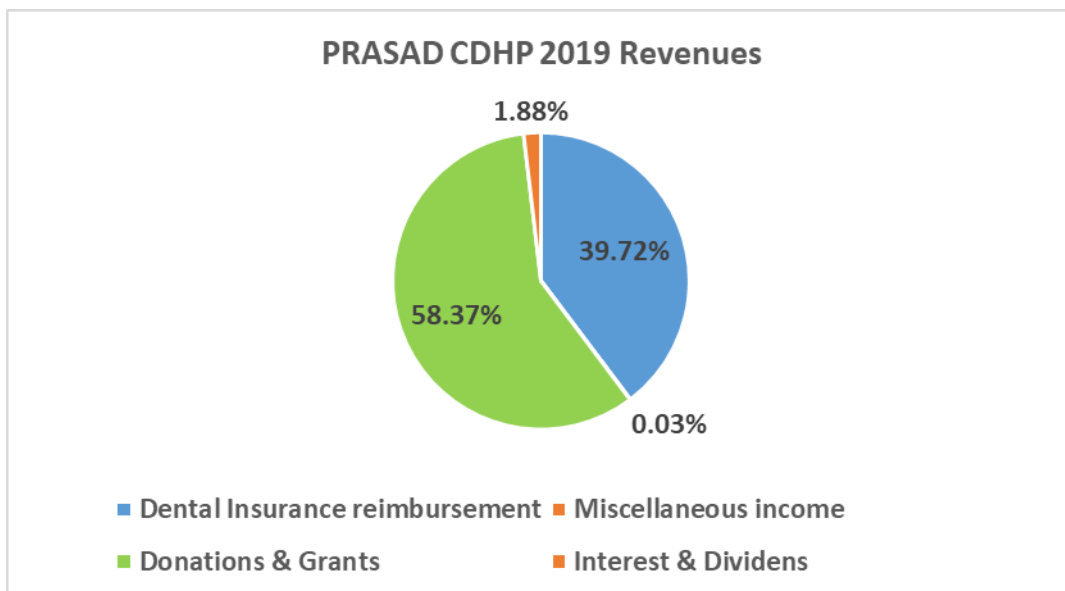
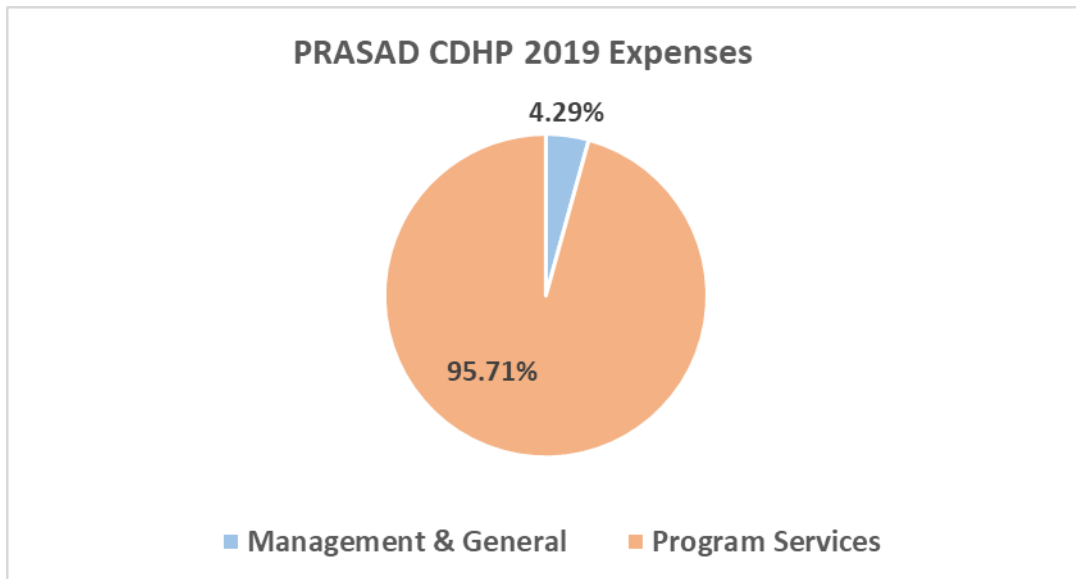
